Members who joined IRTA prior to 2018 can write a \$40 check each year to maintain membership. Since 2019, all new members are required to use **Dues Deduct** from their monthly pension check. Your membership in IRTA has many benefits. It is the State Association that protects your pension and benefits. IRTA LAWSUIT AGAINST CMS:

Presently the IRTA's Attorney is in negotiations with the Attorney General's office to settle the questions that brought about the lawsuit. The increase in funding from the Federal Government for Medicare Part C Programs has helped solve part of the problem created by CMS reducing funds for the THIS (Teachers Health Insurance Services) program.

Minutes of the Clinton County Retired Teachers Association

December 1, 2022 at Bretz's Winery in Carlyle

The meeting was called to order by President Don Ostrom at 11:30 am. After the Pledge of Allegiance, guests were introduced. We welcomed Elaine Hortsmann from Bartelso, Monique Liguori-Weinberg from Trenton, and Pat Bagby from Swansea.

Report from IRTA Treasurer Donnie Ostrom:

- TRAIL Insurance is an important part of our retirement benefit. The new AETNA PPO plan has a reduced premium, and this premium should not increase for five years.
- He encouraged members to read the IRTA Good Dog News Letter which is sent each week via email. Jim Bachmann, IRTA Executive Director is available for questions each month during the on-line session "Coffee with Jim". Members can log in and hear questions and answers.
- IRTA filed a lawsuit against the State of Illinois because the state budget reduced the amount the districts and employees pay into THIS for health insurance. IRTA hired an actuary to determine the effect of reduced contributions from teachers and the state of Illinois.
- The IRTA Area Conferences will be held via Zoom. Members can register for any of the conferences; however, our Area 6 conference is September 6, 2023.

Old Business: Minutes from the Sept 2, 2022 meeting as printed in the newsletter were approved. Treasurer's report as printed in the newsletter was accepted. Treasurer, Pehg Zeller, reported a balance of \$633.14 in the checking account. Dues for the 2023 year are \$10.00 and members can pay at a meeting or mail a check to: Pehg Zeller, 432 North Maple, Trenton, II 62293

New Business: Mary Ann Kauling, membership chair, reported 3 new members joined our group. She has sent letters and called new retirees to encourage them to come to our meetings. CCRTA PROGRAMS:

If you have an idea or would like to provide a program at CCRTA, please let one of the CCRTA Officers know or who to contact. Programs are an integral part of the CCRTA meeting and can provide the members with a wide variety of information and entertainment. Your suggestions and information makes our meetings worth attending.

It is imperative that the meetings have some substance and also provide individuals with the time to visit with friends. We are not a political organization. The foundations of IRTA and CCRTA are to provide protection and information about pensions and benefits. The CCRTA is here to provide information that will make decisions easier for its members.

I believe it is important to hear from our representatives in political office and those who control our pension and benefits. There are people who have the knowledge and capability to answer our questions. The IRTA Executive Director sits on the CMS insurance Board. So, if there are insurance questions, he can provide the answers to your questions. Never be afraid to call the IRTA office for assistance or help with health insurance issues. The best thing you can do with insurance questions is to call the number on the back of your insurance card.

IRTA 2023 EXCELLENCE IN EDUCATION GRANTS FOR TEACHERS:

Each year the IRTA provides \$42,000.00 in grant funds to classroom teachers throughout the State of Illinois. The forms can be downloaded, completed and submitted on-line. Any teacher can visit the IRTA website and download the information at irtaonline.org or e-mail irta@irtaonline.org or call 1-800-728-4782. I have sent every Superintendent in Clinton County the information with a copy of the grant information.

SUGGESTED IRTA CONSTITUTIONAL CHANGES:

IRTA President Bill Funkhouser appointed a committee to review and suggest necessary changes to the IRTA Constitution to streamline the organization and make it more effective. The Executive Board has received the recommendations and I will present their findings at our March meeting.

EDUCATIONAL WEBINARS PROVIDED BY AMBA:

The AMBA is providing webinars on multiple topics. Several have been presented already this year. The topics range from finances, healthcare, insurance and many other topics. Please look through your e-mails from IRTA on upcoming webinars.

<u>3% COST OF LIVING ADJUSTMENT ON FEBRUARY CHECK:</u>

Each TRS annuitant should have received their annual cost of living of 3% on their February check. You can thank the IRTA for preserving this cost of living benefit. This annual benefit was protected when IRTA sued the State of Illinois almost 10 years ago. You should have received an e-mail from IRTA with a video made by Membership Chair Mike Schmidt.

If your February check does not show an increase, you must call TRS and seek an answer to the problem. At this time, I have not heard of anyone not receiving the increase on their February check.

PROPOSED IRTA CONSTITUTIONAL CHANGES

President Bill Funkhouser appointed a Constitution Committee to review the IRTA Constitution and make changes that will streamline the organization and make it more efficient. The Executive Board several years ago hired a consultant to review the IRTA procedures and processes to make it a long-term sustainable organization that meets the needs of its members.

The Committee brought forth the following recommendations for changes:

- 1. Remove Article III, Section 4, and place the procedure for changing how dues are increased from passage at the convention to being part of the "Standing Rules". The Constitution contains the fundamental operating principles that govern its operation. The "Standing Rules" establish specific rules by which the group is to function.
- 2. Change Article VI, Section 1., A. Prior to Convention, active members shall have the ability to elect officers; elect Area Representatives; and Amend the Constitution. Prior to this proposal, Officers and Area Representatives are elected at the Convention by less than 1% of the members. Under this proposal all annuitant members of IRTA, (in-state and Out-of-State), will vote for officers and Area Representatives and Constitutional changes.
- **3.** Change to Article VII. Presently the Board of Directors consists of Officers, Area Directors and Regional Directors. That is 33 people. The proposal suggests that the Board be made up of elected officers and Area Directors. This would be a Board of 10 people. This proposal would do away with the position of Regional Director. This would make the Executive Board the governing body of IRTA.
- 4. Changes to Article VIII. This would change the divisions of the Association to read "Areas and Units". There would no longer be regions. The Association has found it difficult to find individuals to fill these positions and their role has basically become irrelevant.
- 5. Changes to Article IX. This identifies the Standing Committees: Finance, Legislative, Member Benefits, Membership and Leadership Development. Leadership used to be the Nominations Committee. This changes the committee's name and includes a new role of finding and helping individuals to take leadership roles. The Legislative, Member Benefits, and Membership committees would be made up of persons from the Units assigned to that role. This allows for a more active role of each unit.

These proposals will be voted on at the October IRTA Convention. Only those in attendance at the convention will have a role in these changes. By making these changes, ALL members of IRTA will have a say in how the organization functions.

Please feel free to comment on these proposed changes and ask questions. All members will be receiving a PRO and CON sheet from IRTA that explains the rational behind the proposals.

H.R. 82 Has Gotten 128 Co-signers for Repeal in One Month!

The Social Security Fairness Act to repeal WEP and GPO, <u>H.R. 82</u> (same number as last year) was introduced a month ago by Garret Graves, Republican Congressman from Louisiana, and co-sponsored again by Abigail Spanberger, Democrat from Virginia. Our team from <u>ssfairness.org</u> is working with the National WEP/GPO Repeal Task Force to coordinate the effort for repeal with our Congressional offices. The sponsors expect that a Social Security Fairness bill will be introduced in the Senate by the end of this month.

The message to us now from the H.R. 82 sponsors is:

GET MORE CO-SPONSORS!

You can sort the list "from last to first" to see if your Rep. has recently signed on. Make your case by email, by phone and at both their District and D.C. offices.

If they are already on there, send a thank you, and, as with all good communication, give them your best shot. Compose one good sentence to explain how unfair your penalty is. Here are some samples:

- I was never told my Social Security retirement benefits would not be what the yearly notices from the SSA said they would be.
- I was dependent on my spouse for many years before becoming a teacher. Now my partial pension eliminates ALL my spousal/survivor benefits.
- My pension is not enough to live on, AND the WEP/GPO eliminates most/all of the Social Security benefits I paid for.
- Losing all Social Security survivor benefits has made me sell my home and move away from my family and friends.
- In my divorce I had to give my husband half my pension, but now I can't get any of the Social Security spousal retirement benefits our joint income paid for.
