The cost is \$2.50 a month and is deducted from your pension check. You can become a life time member with a one -time payment of \$400.00. Members who joined IRTA prior to 2018 can write a \$40 check each year to maintain membership. Since 2019, all new members were required to use **Dues Deduct** from their monthly pension check. Your membership in IRTA has many benefits. It is the State Association that protects your pension and benefits. A member has access to group plans that sell dental and vision insurance, life insurance, and discounts on travel and hotels. These are only a few of the benefits offered by IRTA to its members.

Government Affairs Coordinator

In 2018, Mary Shaw, the IRTA Grassroots Coordinator for Government Affairs, passed away. Since that time Jim Bachman, the IRTA Executive Director has been looking for someone to fill that position. The position requires a working knowledge of the Illinois legislature and a relationship with those legislators. Mr. Bachman is in the process of interviewing a candidate that has the qualifications necessary to fill that position.

IRTA Building Loan

The IRTA building at 828 S. 2nd Street loan is due to be renewed. The Executive Committee is in the process of renewing the loan on the building. The organization owes approximately \$500,000.00 on the building. The committee would like to pay off the loan in five to eight years and are presently reviewing bank offers to provide said loan.

Minutes of the Clinton County Retired Teachers Association

December 5, 2019 at Bretz Winery, Carlyle, IL.

The meeting was called to order by President Kelley Kesterson at 11:35 am. The Pledge of Allegiance and prayer were led by Leon Luber. Current CCRTA officers were introduced, as well as guest, Ron Daniels, Regional Superintendent. Spouses of members were also introduced.

The Carlyle High School Band, under the direction of Mrs. Jamie Zettler, performed Christmas music. Our group enjoyed hearing the holiday music performed by various ensembles. Mrs. Zettler explained that half the band was performing elsewhere.

Donnie Ostrom reported that this was his last meeting as IRTA Region 16 Director. A member from Hamilton County will be the new Region 16 Director. Donnie Ostrom was elected as IRTA Treasurer at the IRTA Convention in October. Donnie reported that IRTA needs to add new members because we lose approximately 1200 members per year as our membership ages.

Old Business: Minutes of the September 5, 2019 meeting published in the newsletter were approved. Motion to approve by Vernette Homann and seconded by Pehg Zeller. Approved by acclamation.

Jan Kauling, Treasurer, reported Checking account balance is \$193.91 and Savings account balance is \$3287.20. She said it was necessary to transfer \$100.00 from savings to checking because the checking account was less than \$100.00. The accounts were audited by Milton Luginbuhl and no irregularities were found. Jan collected CCRTA dues for 2020. Jan Kauling and Paula Williams will go to the bank and complete new signature cards for both checking and savings accounts. Jan Kauling will remain on the signature card and Milton Luginbuhl will be removed from both accounts. Motion to approve treasurer's report by Jan Wilsey, seconded by Milton Luginbuhl. Approved by acclamation.

Ron Daniels, Regional Superintendent spoke to the group about the importance of contacting legislators concerning any bills that affect education or education budgets. He asked retired teachers to encourage young students to become teachers, the need is great. He reminded us that schools desperately need substitute teachers and there are still some open positions that schools cannot fill because of lack of qualified applicants. Teachers need to keep their ELIS account current on line because teachers certificate notices are only sent via email. The good news is that schools are in a much better financial position this year.

New Business: Election of Officers for 2020-2021. Donnie Ostrom was nominated for President. Motion by Janis Seiffert, second by Beth Pebbles. No other nominations were made and Donnie was elected by acclamation. There was no candidate for Vice President and no nominations from the floor. The office of Vice President will remain open at this time. Kay Ostrom was nominated for Secretary; motion by Carol Moeller, second by Paula Williams. No other nominations were made and Kay was elected by acclamation. Paula Williams was nominated for office of Treasurer. Motion by Donnie Ostrom and second by Leon Luber; as there were no other nominations from the floor, Paula was elected by acclamation.

Kelley Kesterson, as a member of the IRTA Legislative committee, reported that there is no new legislation affecting our pension and benefits at this time. He encouraged all members to invite other retirees to the next meeting.

Membership report: There were 41 people in attendance and 2 spouses. Mary Ann appreciates that members RSVP before the next meeting so that she can contact the restaurant.

Donations to IRTA Foundation were collected and will be donated in memory of Jane Bachman, wife of Jim Bachman, Executive Director of IRTA. Jane passed away in late October.

A special thank you to Jan Kauling for serving more than a dozen years as Treasurer of Clinton County Retired Teachers Association. We appreciate a job well done.

Motion by Jan Wilsey and second by Patti Ritzheimer to adjourn. Meeting adjourned at 1:30pm.
