l recommend that you also join the Illinois Retired Teachers Association in Springfield. You may go online for information at www.irtaonline.org. The cost is \$2.50 a month and is deducted from your pension check. You can become a life time member with a one-time payment of \$400.00. Members who joined IRTA prior to 2018 can write a \$40 check each year to maintain membership. Since 2019, all new members were required to use **Dues Deduct** from their monthly pension check. Your membership in IRTA has many benefits. It is the State Association that protects your pension and benefits. A member has access to group plans that sell dental and vision insurance, life insurance, and discounts on travel and hotels. These are only a few of the benefits offered by IRTA to its members.

News From The IRTA Office in Springfield



2021 IRTA Area Conferences and Fall Convention:

The Illinois Retired Teaches Association Governing Board has decid-

ed to hold all <u>Area Conferences</u> on-line this year. After discussions with the Illinois Department of Public Health and IRTA Area Directors, the Board decided it would hold conferences on-line. The Board determined in order to meet the health and safety needs of its members that they would use an on-line meeting platform. The on-line Area Conferences will be held in June. The date will be determined later. More information will be sent to each member.

2021 IRTA Biennial Convention in October:

The Board has moved forward with having an in-person convention in October of 2021. It is hoped by then the COVID-19 Virus will be under control and that most things will be back to near normal. The Convention Committee is meeting and planning all the activities for the fall convention scheduled for October 18th and 19th. I will again be running for the Office of Treasurer of the Illinois Retired Teachers Association. Our former Area 6 Director and now Vice-President of IRTA, Bill Funkhauser, will be running for the office of President of IRTA.

TRS Representatives and IRTA Board Have Met and Discussed Information Sharing:

The two entities had a ZOOM Meeting to discuss how the two organizations can work together and share information. TRS has determined that IRTA can help in providing information about TRS activities to the members of IRTA. I will be adding to the newsletter the information garnered from the meeting. I have the presentation in a format that can be sent to any CCRTA member. If you are interested in the information shared by TRS, please let me know.

The IRTA Executive Board is Looking at Changing the Officer Election Process:

The IRTA Executive Board is reviewing the Election process for its Board of Directors. Presently officers (President, Vice-President, Secretary and Treasurer) are elected by delegates at the Biennial Convention. The discussion has been to open the election process so that each member of IRTA would have one vote instead of delegates from each Unit.. This discussion is in the early stages and is being reviewed by the Board of Directors. As the discussions go forward, if you have an opinion, please let me know.

BOND COUNTY RTA CLOSES:

The Bond County Unit decided to close its door. According to its President, they were not finding people to become officers and although the younger retirees joined the unit, they did not attend the meetings. I have invited the members of Bond County to join Clinton County Retired Teachers Association. The IRTA Executive Board is seeing several Units across the state looking to close their doors due to the same factors. This should come as a warning to all that if we don't support our local Units, the possibility exists that the legislators will take that as a sign they can change pension and benefits. Please encourage the new retirees to join and remind teachers that we are supporting them with grants, scholarships, and with the legislators.

PRESIDENT JOSEPH BIDEN SUPPORTS ENDING WEP AND GPO:

The Biden/Harris administration has notified the U.S. House of Representatives and Senate that they would support ending the W.E.P. (Windfall Elimination Provision) and G.P.O. (Government Pension Offset) during their tenure in office. What does this mean for retired teachers? The only Bill that was submitted last year was submitted by Rodney Davis (R) of Illinois and Adam Schiff (D) of California. This Bill would only allow individuals who retired after 2021 to be able to collect full Social Security benefits. If the same bill is resubmitted those who are already retired would not be affected and would still be unable to collect full Social Security benefits.

If you collect a public retirement under these rules, you cannot collect full Social Security benefits. If your spouse dies and you are collecting a Public Pension, you cannot collect any of their Social Security benefits. Many of the teachers whose husbands farmed or owned a business and paid full Social Security are not entitled to collect any of their spouses' benefits.

The Illinois Retired Teachers Association has, several times over the years, attempted to work with Illinois' congressional delegations to have these laws repealed. We are one of fourteen States that has this issue under Federal Law. We are hoping that during this administration a repeal can take place. It is still a big hurdle to get over. There are several states that are pushing their Representatives to sign-on and promote the repeal of WEP and GPO. As information becomes available, I will keep you informed. Please let your U.S. Congressman know that you would like to see this happen.



THE COVID-19 VACCINE FOR CLINTON COUNTY

I have spoken with Clinton County Superintendents who have told me their staff has been given their first vaccine shot and sometime in February will

be given their second vaccine shot.

I spoke with the Clinton County Health Department and they have a sign-up form on their website. You will need to fill out the on-line form in order to receive the vaccine through the Health Department. They also said that some of the communities are establishing lists of those who would like the vaccine. I saw on the St. Rose School website that they are taking the names of those over 65, who live in St. Rose, and they will be giving out vaccine shots in the next few week at the St. Rose Development Club. Please check in your community to see if they are setting up vaccine sites.

If you do not have access to a computer, please call the Clinton County Health Department and they should put you on their list.

This is how the IRTA Board and all IRTA committees are now meeting to conduct business.

I would like CCRTA members to let me know if they are interested. Simply e-mail or phone me with your answer. I am attaching to this missive, instructions on how to install Zoom on your computer or cell phone to be able to be part of a CCRTA Zoom meeting. ZOOM is free to the users. You need to download this program and follow the instructions on the attached sheets. I bought ZOOM Pro for my home computer which will allow me to set up meetings of more than 40 participants.

Should you feel uncomfortable installing the zoom program, please feel free to call me (618) 604-9544 and I will help you download the program to your computer or phone. My wife says, that if I can do it, anyone can. We should be able to conduct a regular CCR-TA meeting. I promise that these meeting will last no longer than 30 minutes to an hour.



A Step-by-Step Guide to a Zoom Meeting

If you haven't already received an email inviting you to a Zoom meeting, you probably will soon. In this age of social distancing, many groups are choosing to meet virtually, and Zoom is one of the most popular ways to do this. It might be your book club, your volunteer group, or your Sunday school class, but chances are you're going to be part of a Zoom meeting.



This article only covers joining and participating in a Zoom meeting that you've been invited to. If you want to know more about more advanced Zoom features like changing your background, raising your hand in a meeting, sharing your screen, and hosting your own meeting go to Zoom's Support Center support.zoom.us/hc/en-us

DOWNLOAD ZOOM

Zoom is a program that runs on your computer, phone, or tablet. You must download this program from the Zoom website. The free version of Zoom should meet all of your needs.

If you've received an email invitation to a Zoom meeting, click the link that says, "Join Zoom Meeting." If this is the first time you've used Zoom, this link will take you to a website where you can download the Zoom program or app, depending on what device you're using.



On an iPhone or iPad: Go to the Apple App Store and search for "ZOOM Cloud Meetings." Click "Get" to download and install the Zoom app.

On an Android phone or tablet: Go to the Google Play App Store and search for "Zoom Cloud Meetings." Click "Install."

On a computer: On the Download Center website **zoom.us/download**, click "Download" in the "Zoom Client for Meetings" section.

Click the blue Download button to download Zoom from the website zoom.us/download

After Zoom is downloaded, you must install it onto your computer.

If you have an Apple computer, like a MacBook:

Double-click the file called *Zoom.pkg*, which is typically saved to your Downloads folder. The installer program opens and guides you through the process.

If you have a PC: Double-click the file called *ZoomInstaller.exe* file to install the program.



Double-click ZoomInstaller.exe to install Zoom on your PC.



JOIN A MEETING

After you install Zoom, there are a few different ways to join a Zoom meeting. You can click the link in your invitation email, go to the Zoom website and enter the meeting ID, or dial into the meeting on a phone.

Click the link in an invitation email: If you have an email invitation, click "Join Zoom Meeting" in that email. This takes you to the Zoom website.

Go to the Zoom website: Go to zoom.us/join, and enter the 9-digit meeting ID from your invitation email. If the meeting requires a password, that will be in your email, too.



When you are on the Zoom website, if you are asked if you want to open Zoom, click "Open zoom.us." Zoom opens, showing you a preview of your camera image. Then click either "Join with Video" or "Join without Video." If you use video, other people in the meeting will see you. If not, they will just see your name. Next, Zoom asks about audio. Click "Join with Computer Audio" so you can hear and be heard in the meeting.

Dial into the meeting on a phone: If you don't have access to a computer, tablet, or smartphone, you can use a phone to dial into the meeting. The phone number to use will be in your invitation email, or you can find the number to use in the Zoom International Dial-in Numbers list zoom.us/zoomconference.

PARTICIPATE IN A MEETING

Once you've joined the meeting, you can see and hear other participants. Each participant is represented by a square that displays their face *(if they've chosen to join with video)* or just their name.

If you're in a large meeting, make sure your microphone is muted. Your computer microphone is pretty sensitive, and if you're unmuted, it can pick up a lot of background noise. The mute button, which looks like a microphone, is in the bottom left corner of the Zoom screen. If the microphone has a red line through it, you're muted, and no one in the meeting can hear you.



If the microphone has a red line through it, you are muted.

Click the button again to unmute yourself if you want to talk in the meeting.



If the microphone has no red line through it, you can be heard in the meeting.

Only one person in the meeting can talk at a time. Zoom indicates who is speaking by highlighting their image with a yellow square.

There is also a chat feature in Zoom, where you can type messages to other participants. Participants can send messages to everyone in the meeting, or just certain participants. However, after the meeting, the host can view the transcript of all chats, so it's not entirely private. If there is a message for you in the chat, a notification appears on the Chat button, which looks like a speech bubble. Click that button to open the chat window.

LEAVE A ZOOM MEETING

Click "Leave Meeting" on the bottom right corner to leave the meeting.
